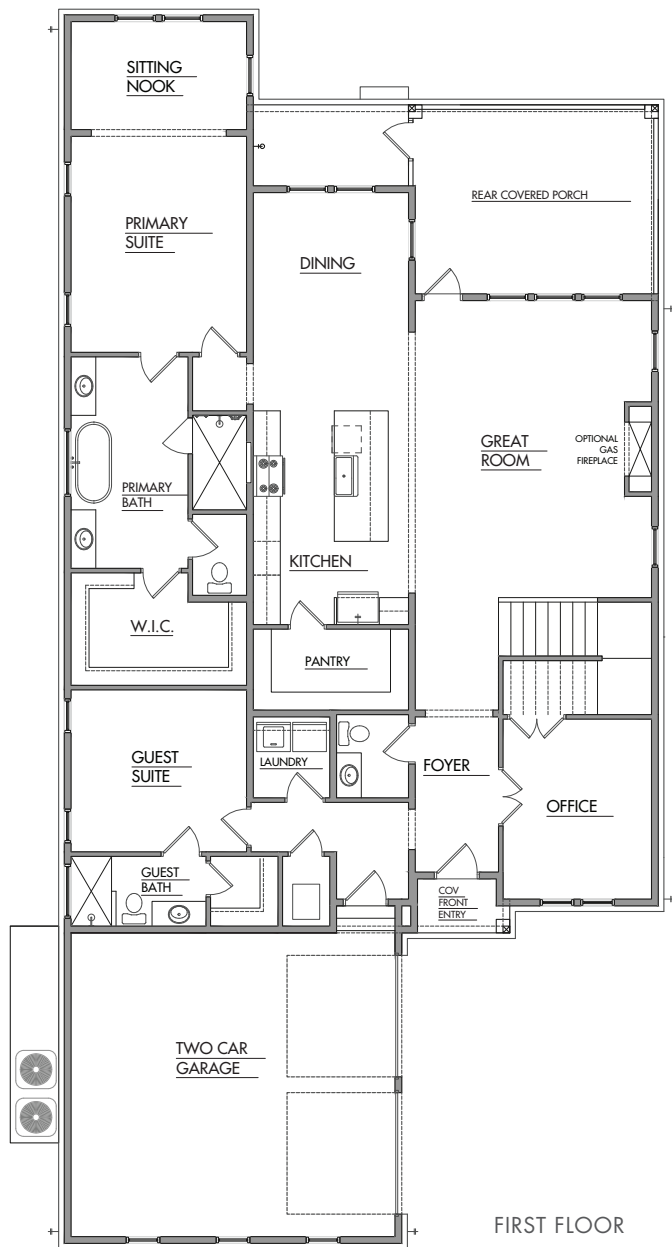


FRONT VIEW

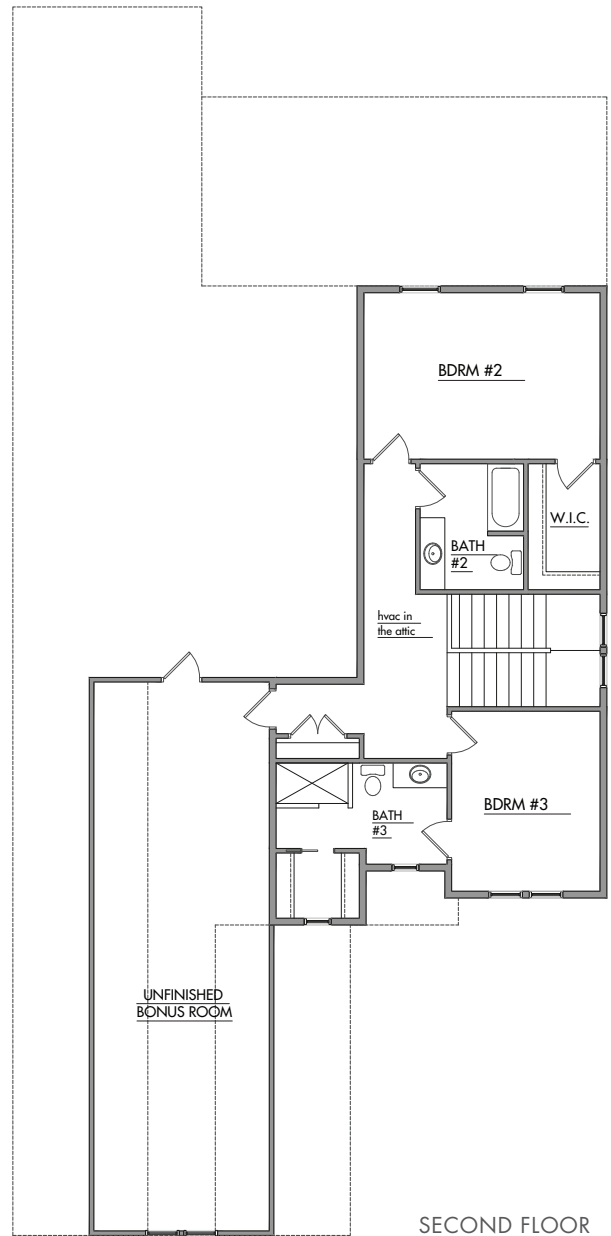
